- Dr. Pulliam advised that service report should be shown quarterly as well as where we are with numbers.



- Next Commissioners Board Meeting will be held on October 3rd at 7pm Clayton Board Members will be in attendance. Approval of County Funds are supposed to be on agenda for Commissioners' vote.




